

Expression of Interest

Association of State Road Transport Undertakings (ASRTU) is an autonomous body work under the aegis of Ministry of Road Transport & Highways and Secretary RT&H is the ex officio president of ASRTU.

ASRTU is calling for Expression of Interest (EOI) for converting HT connection to LT Connection. In this regard transformer and upto meter shall be within the scope of BSES. Beyond Meter laying down cable upto LT Panel, Providing On Off switch shall be carried out by the shortlisted agency. The work is divided into two parts.

Part-I

- (a) Laying down cable from BSES Meter to LT Panel, Providing On Off switch,
- (b) Removing existing cables from existing HT Meter, HT Panel, Transformer and upto LT Panel and make it ready for scrap.

Entire work has to be carried out as per the following strict safety procedure and laid down procedure of BSES. No scope of loose wire, earthling leakage or any defect is acceptable. Agency should be authorized by BSES and agency's details shall be informed to BSES and Central Electric Authority in the event of any wrong doing or bad workman ship to blacklist the agency.

Shortlisted agency may bring cables switches and claim the amount for reimbursement from ASRTU against the proof of purchase and pass on warranty/guarantee. Procurement of cables and switches shall be made in the name of ASRTU for coverage of warranty and guarantee. Separate rates may be quoted for laying down cables fixing switches and removal of existing cables. Existing cables shall be removed in such a manner so that the cable can be used elsewhere or scrapped immediately without incurring any cost. Agency has to ensure there shall not be any equipment or workmanship defect lies on the part of them. Interested agency may visit ASRTU Bhawan and inspect the set up to measure length of cable needed to be laid down. Switches details and offer their competitive rates for each work.

Part-II

- (a) Scrapping of existing HT Panel
- (b) Scrapping of existing 420 KVA Voltamp dry type Transformer

Interested agency are invited to inspected these working equipment and may send sealed quotation separately as is where is basis quote. The highest bid agency will be shortlisted for scrap award for HT Panel and 420 KVA Voltamp Transformer. There may be separate agencies (i) for laying down cable and fixing up switches and (ii) Scrapping of HT Panel & Transformer. No amount shall be paid for visiting and inspection charges and offering quotes. Initially agency may be shortlisted for Part-I job. The agency will have to ensure the minimum breakdown or idle time and will have to work in tandem with BSES representatives during holidays so that uninterrupted power supply shall remain available for smooth working of office. Interested parties may send their credentials, accreditation, GST details along with financial quotes in a separate envelop super scribing subject

- 1. Technical Commercial Quote for Laying down cable & switches
- 2. Technical Commercial Quote for Scrapping of HT Panel & Transformer

And separates quotes for

- 1. Financial Quote for Laying down cable & switches
- 2. Financial Quote for Scrapping of HT Panel & Transfomer
